CYBER BULLYING TERROR ON INTERNET

Today, young people make friends on the internet without thinking. Share everything with them. Many times, strangers also start harassing them after knowing their personal secrets.

The risk of cyber mobbing in India is increasing rapidly. The trend of bullying, harassment and blackmailing teenagers and children in the country is increasing rapidly. Some similar incidents have happened recently. Vivek studying in a Kanpur school became a victim of cyber bullying. Due to the horror of some rogue youths, Vivek now neither works on computer nor goes to play in the school grounds. He is constantly looking at the sky.

A note was found in his room in which he alleged that two former college students allegedly harassed him by making objectionable comments about him on Facebook.

Similarly, Neelam, a promising girl studying in IMA in Bengaluru, also committed suicide. Neelam broke up from her boyfriend and when she woke up in the morning, the young man had allegedly written on Facebook. 'I am feeling super cool because I have left my girlfriends.' After this Neelam committed suicide. In a school in Allahabad, Nishi was thrown out of his group by his friends on a minor matter because his school boy was heard from a group. To avenge her, the children of her class deleted Nishi from the WhatsApp group and unfollowed it from Facebook. Nishi, 16, felt insulted by this.

They do not understand that in such a situation their private life becomes public rather than their own. Then every aspect of their life is in front of the world.
